
## **Passenger Vans**

Any driver of a 15-passenger van must hold a California Commercial Driver's license Class B with a passenger endorsement and comply with all driver requirements, including random controlled substances and alcohol use testing. A 15-passenger van converted to a 12 or 10-passenger van is still considered a 15-passenger van, and the driver requirements apply.

Any vehicle designed to carry more than ten (10) persons to and from school events, or any vehicle transporting two or more students who use wheelchairs, should be equipped with the following:

- 1. Lamps, reflective devices, and associated equipment,
- 2. A stop signal arm,
- 3. Emergency exits and window retention and release,
- 4. Body joint strength,
- 5. Passenger seating protection, and
- 6. Passenger crash protection.

A 10-passenger van carrying students (9 students and a driver) is classified as a passenger vehicle; however, when the vehicle



When charging a fee to transport students in a vehicle designed for 11 or more passengers, the vehicle may be considered a tour bus. Clarification should be obtained from the local California Highway Patrol (CHP) office as to their interpretation of tour bus operator requirements. Each local CHP office has its own jurisdiction and discretion to interpret regulations. Whenever possible, consider avoiding charging students a separate transportation fee.

## **Best Practices:**

- DMV Pull Notice System Staff that routinely drive district vehicles should be added to this system for monitoring.
- Defensive Driver training Staff should be trained regularly on the safe operation of vehicles.
- Vehicle maintenance and condition It is the joint responsibility of drivers and maintenance staff to maintain the safe operation of all vehicles. Any deficiencies should be reported immediately.
